Appeals

1. The Final Grade Appeal form must be completed in its entirety and returned to the Registrar's Office along with the required fee of \$42, which is refundable if appeal is successful.
2. You are required to file an appeal within ten (10) business days from the date that the grade is posted on myVCC. Appeal requests received after ten (10) business days may be considered at the sole discretion of the Dean. The student must accompany this form with a written explanation of valid reasons why an extension to the deadline is warranted.
3. The Dean will determine whether there are sufficient grounds to proceed with an appeal.
4. If grounds for your appeal are established, you will be contacted by the Dean's Office for a meeting and provided with information about the process and next steps of your appeal. All questions about your appeal should be directed to the Dean and/or discussed with your SUVCC Student Advocate.
5. If grounds for your appeal are not established, you will be notified and provided with a rationale by the Dean. Contact your SUVCC Student Advocate about how to proceed with a potential petition of the Dean's decision not to proceed with your Final Grade Appeal through an appeal to Education Council on Academic Matters (see Policy 321).
